In 2025 the EAC has granted ECs to 10 HEPs of total 11,084 Mw capacity and cleared ToR for 1 HEP of 82.5 Mw capacity in Himalayan states. The maximum 4 HEPs of 7,217 Mw capacity were granted EC in Arunachal Pradesh, followed by 3 HEPs of 2,256 Mw capacity from J&K and 1 each from Sikkim (1200 Mw), Himachal Pradesh (191 Mw) and Uttarakhand 120 Mw. The 1200 Mw Kalai II HEP was granted both ToR and EC in the year.

In 2025 the EAC has granted ECs to 8 PSPs in 4 states of total 12,890 Mw capacity. This includes Kandhaura PSP (1680 Mw) in UP and Saidongar- Kariat PSP (3000 Mw) which were also granted ToR in 2025. The maximum 4 PSPs were approved for ECs in Maharashtra state of total 7,800 Mw capacity followed by 2 PSPs in Andhra Pradesh of 2150 Mw capacity and 1 each PSP in UP of 1680 Mw and Karnataka of 1260 Mw capacity.

In 2025 the EAC has approved ToR for 26 PSPs in 10 states of 36,860 Mw capacity. The maximum 8 PSPs were granted ToRs in Maharashtra of 12,350 Mw capacity followed by 3 each in Andhra Pradesh (6,600 Mw), Rajasthan (6,010 Mw), Chhattisgarh (3,800 Mw), Madhya Pradesh (3,500 Mw), 2 in Odisha (1,600 Mw) and 1 each in Tamil Nadu (1,000 Mw), Assam (900 Mw), Uttar Pradesh (600 Mw) and Gujarat (500 Mw).

In 2025 the EAC has approved ECs for 3 projects including Renuka dam in Himachal Pradesh, Tembhu Lift Irrigationi Expansion in Madhya Pradesh and Khadakwasala Fursungi Tunnel Project in Maharashtra. The EAC has also granted ToR to 9 other projects including 6 irrigation projects 4 from Madhya Pradesh and 1 each from Uttar Pradesh and Bihar. ToR for 1 Life and 2 Intrastate River link projects from Maharashtra state were cleared during the year.
